Smt. L.R.T. College of Commerce, Akola organized A One day National Level Conference on "New Methodology of NAAC Assessment to Nurture Quality Enhancement in Higher Educational Institutions" in Collaboration with IQAC Cluster Maharashtra. The conference was focused on the periodical changes taken place in process of accreditation by NAAC committee. The main focus of the accreditation procedure of the NAAC is to promote qualititative education. This conference specifically stressed on the role of teachers in teaching students how to think and apply knowledge in real life.

The organization of this conference is a necessity because for an institution accreditation is a necessity as well as a status in an academic spectrum. Dr. Pingle, the Resource person called the teacher as the "Life Creator". He emphasized on raising the benchmarks by the teaching professionals. The other issue discussed prominently was the "Benchmarking" i.e. to set standards on the basis of introspection for continuous improvement of Quality in education sector. The essentials of successful accreditation. viz., Harmonious Relation with College Management, Setting Benchmark for Quality, Emphasizing PDCA approach, study of NAAC manual and Setting target for better score were discussed positively. In this National Conference 73 research papers on the 4 subthemes were contributed by the delegates from all over India.



Impact of Demonstration: On November 3, 2016, the Indian government declared that the 500 and 1000 napee notes will be stripped of their status as legal tender effective from midright. These notes accouncide to 16 percent of the country's cash supply by value. 
# A One Day National Level Conference on "Impact of Recent Indian Agricultural Policy on Agricultural Sector and Other Allied Sectors
